# **MESSAGE FROM THE PRESIDENT**

The Board of Directors met yesterday and some concerns about association violations were discussed. In the last newsletter dated February 19, 2021, Garbage Day procedures were addressed, yet someone continues to put garbage out before 5:00 p.m. almost every Sunday--sometimes as early as Saturday morning. This enforcement will be turned over to the management company for monitoring and potential fines. Other complaints were received and will also be turned over to the management company for enforcement and potential fines: kids playing in the driveway circle-bouncing a ball up against the building, skateboarding, and scooter riding. The Rules and Regulations Booklet prohibits playing in the street, driveway, and parking It also states that skateboards are prohibited lot. from condominium property. I recommend taking skateboards and scooters to the street and proceeding from there at your own risk. I also recommend that kids play either in the grass behind the condos or in the park area. And ongoing complaints are received about people turning into the half-circle driveway too fast, as well as speeding on the street. The speed limit on Landings Way is 15 mph and it is recommended to keep it to 5 mph in the half-circle for the safety of those walking to their cars or the mailbox. So please be mindful. When residents complain about specific rules violations, the Board of Directors and management company have no choice but to respond to that specific complaint.

#### WORK ORDER STATUS

Ice dams caused some initial garage roof leaks this past winter. But after a complete thaw, the leaks stopped, even after some heavy rain periods. In the fall, heat cords will be installed on top of every garage roof to prevent ice dams from forming in the future. All previous work orders have been completed or self-resolved when the weather warmed up, except for some minor holes and some painting. Units 88 and 96's garage ceilings will be patched up/painted. Additionally, two sets of stairs will be fully replaced and painted. (Units 86/87 and 94/95.)
