2022 APPROVED OPERATING BUDGET

Dear Unit Owners:

Enclosed for your information is a copy of your Association's approved 2022 budget. New payment coupons and envelopes will be mailed separately <u>unless</u> you are on the automatic electronic payment program. If you prefer to pay by check, please remember to make your checks payable to *Landings #6 Condominium Association Inc.* Anyone using coupons or your bank's online bill payment system we have a new payment remittance address. Please mail all payments to, *Landings #6 Condominium Association*, *PO Box 97516*, *Las Vegas*, *NV 89193-7516*. This will be the new remittance address for 2022.

The approved 2022 Operating Budget is \$80,135.00, which includes the first year of the roof replacement assessment. Reserve contributions are \$30,000.00; \$24,000.00 is dedicated to the roof assessment to build funds for new roofs. A monthly payment schedule is included for your reference. It should be noted that the unit owners have voted to waive fully funding the reserve account, in the past. Approval of this waiver permits the Board to assess for reserve project funding. As previously discussed, both at the Annual Meeting and through the Association's Newsletter, an assessment has been imposed for a \$24,000 future roofing projects. This assessment is already being factored into your monthly payments starting in 2022.

In addition to this letter and 2022 Budget Summary (on the back of this page), we are also including the Reserve Funding Waiver letter and ballot, with self-addressed and stamped envelope. Please review and return the ballot by November 12, 2021. Also, please be reminded that if the Reserve Funding Waiver does not receive majority approval, there will be a larger increase to the monthly maintenance fee.
